As promised to you at the November 28th meeting of the Pacific Marine Conservation Caucus (MCC) we are pleased to provide you with a fuller description of the makeup and internal structure of the MCC.

MCC Purpose and Guiding Principles

As described in the draft MCC Guiding Principles previously sent to you, the caucus will act as the primary environmental organizations' main method of representing the conservation sector as a "stakeholder" interest in formal DFO consultative processes. Also, the caucus will report to, liaise with, and assist other conservation organizations and streamkeeper/stewardship groups whose concerns are more issue-specific, local, or ancillary mandates and capacity.
